## Canning's Corners


Excerpts by Harry Linney, 1932

While the early Muskoka Road settlements between Severn Bridge and Gravenhurst were the show windows of Muskoka District to the people looking for farms “free for locating,” they did not continue to hold that record for many years, even with the comfortable log houses and tilled patches of wheat, corn, and vegetables, because it was found that the best soil was westward toward Sparrow Lake. The government of the day, under the leadership of Hon. John Sandfield MacDonald, was devoting every energy to the obtaining of population. Hon. John Carling, one of the ministers of government, claimed that the cornerstone of prosperity rested in farm expansion, and that the new North teemed with wealth which would bring to the artisans of the British Isles wealth and contentment. It was in response to appeals of this kind that land was “taken up” by the first settlers in Morrison. This gospel of free land and a farm of one hundred acres for each son in the family was what brought John Canning and his wife, Jane (Winchester), and their ten children.

Originally from Belfast, Ireland, John Canning assisted in forming Bethel Church and was occasionally the preacher. He was active in organizing the Morrison & Ryde Agricultural Society. He devoted time and thought to the forming of the first Orange Lodge in Morrison, which was organized at Severn Bridge in May 1868, called Morrison True Blues 1144. Around the garden in front of his house, Mr. Canning erected a fence built of split cedar palings, the first such fence in Morrison, looked upon as an attraction in those days. At the annual agricultural fair in 1875, Mrs. Michael Clipsham (Charlotte) secured first prize for her butter, and James Clipsham for his team of horses. In 1876, one of the events was the testing of strength and pulling ability of teams of horses. Lumbermen had

offered \$5 as a prize to the winning team. On this summer day of 1876, excitement ran high as the contesting teams were separately hitched to a sleigh loaded with stone, and none could move it more than a few inches—none could drive off with the load. John Roach was given permission to hitch his yoke of oxen to the sleigh, and as his “yoke” walked away with it, to the loud acclaim of the gathered crowd, a dozen men—17 men, one record states—jumped on the load, and the oxen pulled it without hindrance until the sleigh struck a flat stone and the sudden jerk and stopping of sleigh broke the attaching tongue and separated the oxen from their load.

**AGENCY FOR THE SETTLEMENT**  
OF THE  
**Severn and Muskoka Road.**

---

August, 1859.

**T**HE undersigned Agent appointed by His Excellency the Governor General, for the Settlement of the Severn and Muskoka Road, passing through the Townships of Morrison and Muskoka, to the North of Lake Simcoe, Upper Canada, hereby gives notice to all persons willing and having the means of locating thereon, that the Lots on the Road are now ready for location. His Office will be (for the present) at Orillia, and will be open every day in the week from 9 a.m. to 4 p.m.

Grants of One Hundred Acres will be made to any Settler Eighteen Years Old, subject to the following conditions, viz.:

To pay a Fee of Five Dollars; to take possession within one month, and to put in a state of cultivation at least Twelve Acres of Land in the course of Four Years; to build a House (at least 20 x 18) and to reside on the Lot until the conditions of settlement are duly performed; after which accomplishment only shall the settler have the right of obtaining a title of property. Families comprising several settlers entitled to Lands, preferring to reside on a single Lot, will be exempted from the obligation of building and of residence (except upon the Lot on which they live), provided that the required clearing of the Land be made on each Lot. The non-accomplishment of these conditions will cause the immediate loss of the assigned Lot of Land, which will be sold or given to another.

The Road having been opened by the Government, the Settlers are required to keep it in repair.

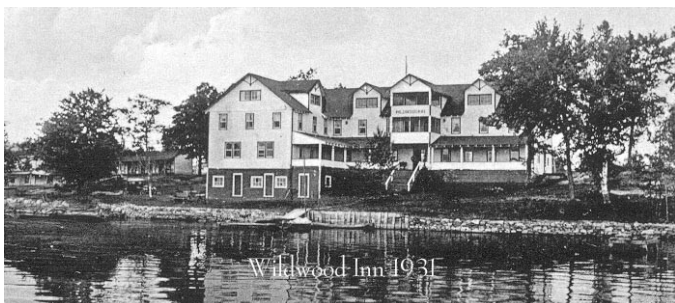
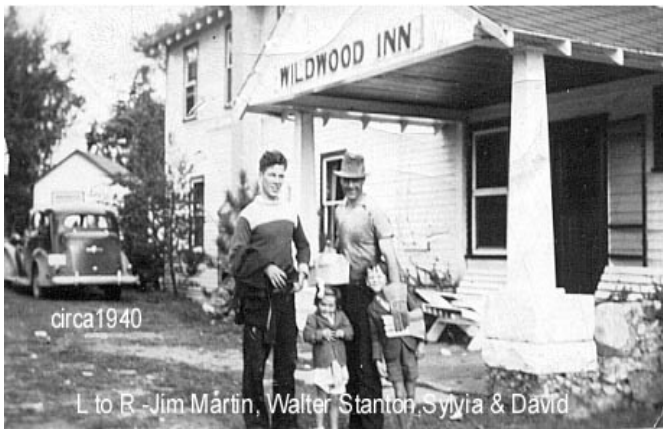

## Bayview-Wildwood Resort

The biggest change around Sparrow Lake during this last winter was the purchase of Bayview-Wildwood Resort in November by Choice Hotels Canada under their Ascend Hotel Collection—a network of sixteen upscale resorts, historic properties and boutique hotels that offer guests a uniquely local experience.

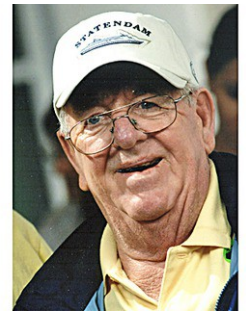


The original main lodge known as Wildwood Inn was built by Walter and Eleanore Stanton in 1931. Walter was a grandson of pioneer Thomas Stanton, and the resort was built on the former

site of the Stanton sawmill. In 1954, after Eleanore developed terminal cancer, Walter's younger brother Ernest Stanton purchased the resort. In 1955, his son Ronald and Irene Stanton took over Bayview Lodge management and soon combined both properties under the name Bayview-Wildwood Resorts Limited.



During his illustrious career as hotelier, Ronald Stanton amalgamated Wildwood Inn, Lakeshore House, Bayview Lodge, Martin's Tourist Supplies and Wild Echo Lodge into the Bayview-Wildwood Resort complex, and also founded the fractional ownership development known as The Cottages at Port Stanton. Ronald Stanton continued to oversee corporate operations until his death on June 10, 2014 at age 77.



Hotel activities today include fine dining, breakfast buffet, badminton, bicycle rentals, billiards, kayaking & canoeing, tennis, cross-country skiing, shuffleboard, volleyball, and a sandy beach with water park. In addition, there are two pools – indoor and outdoor – and a fitness room. Corporate travellers have access to a business conference centre with meeting rooms and banquet space. The new manager is Jason Stanton, keeping continuity with a proud family tradition.
